I: Applicant Eligibility

Eligible applicants must meet MOE Regulations Regarding International Students Undertaking Studies in Taiwan

(For regulations, please see Appendix on p.11)

Eligibility criteria for the above-mentioned application:

1.For admission to Bachelor Programs: High school diploma.

2.For admission to Master's Programs: Bachelor's degree.

3. For admission to Doctoral Programs: Master's degree

*Due to different education systems in each country, applicants who graduate the same year as their admissions to National Taiwan Normal University should ensure that they receive their diploma and academic transcript by the deadline specified for the chosen semester (Applicants applying with diplomas or degree certificates from Mainland China are required to have the documents notarized by the relevant authorities). Applicants must meet the above requirement to be qualified to apply. Fall 2020: August 31, 2020 Spring 2021: January 31, 2021 Fall 2021: August 31, 2021 Spring 2022: January 31, 2022

Note 1

According to Article 2 of the *Nationality Law*, a person who meets one of the following requirements acquires Republic of China nationality:

• A person whose father or mother was, at the time of his/her birth, a citizen of the Republic of China.*

A person born after the death of his/her father or mother, and whose parent was, at the time of death, a citizen of the Republic of China.*

3A person born in the territory of the Republic of China and whose parents are both unknown or are stateless.

4 A naturalized citizen.

* An individual born on or before February 9, 1980 needs only consider the nationality of his or her father.

Note 2

As stated in the *Regulations Regarding Study and Counseling Assistance for Overseas Chinese Students in Taiwan*, "Overseas Chinese Students who have graduated, been expelled, or been suspended from their studies for longer than the maximum allowable duration will lose their status as an overseas Chinese student (...) Students whose status has been temporarily suspended will resume their status upon returning to school." Anyone meeting one of the following requirements is considered overseas Chinese, and therefore is disqualified for applying as an International Student:

Anyone having previously studied at the Division of Preparatory Programs for Overseas Chinese Students at National Taiwan Normal University (formerly known as National University of Preparatory School for Overseas Chinese Students).

Anyone having applied for studies or previously studied in any school in Taiwan as an overseas Chinese.

③Anyone having taken the university entrance exam for overseas Chinese students held by the University Entrance Committee for Overseas Chinese Students and who has filled out preferences for a university/college and has been admitted to one of those universities/colleges.

2. Application submission

- 2 Applicants applying for two programs or more, or applying for different divisions at the same department/graduate institute, should submit their applications separately to each department/graduate institute and each division.

3. Fees and payment

such as entry and departure records for the past 6 years, a declaration form stating that they do not hold a a R.O.C. household registration (see Attachment III, p.25), Certificate of Nationality Renouncement of Republic of China or other documentation.

5Diploma of the highest academic degree.

- A copy of the applicant's highest-level diploma in Chinese or translated into English. (Admitted students must submit their original diploma for review to the Office of International Affairs on the day of enrollment.) Applicants applying with diplomas or degree certificates from Mainland China are required to have the documents notarized by the relevant authorities.
- A copy of the applicant's complete transcripts (for ALL years of study) in Chinese or translated into English. (Admitted students must submit their original transcripts for review to the Office of International Affairs on the day of enrollment.) Applicants applying with diplomas or degree certificates from Mainland China are required to have the documents notarized by the relevant authorities.
 - *Applicants applying with diplomas or degree certificates from Mainland China are required to have the documents notarized by relevant authorities. If authentication can not be completed by the application deadline, please submit degree certificate, a complete transcript and a signed Deposition of Admission Documents (see Attachment V, p.27).
 - *Eligible applicants who graduate the same year as their admission to National Taiwan Normal University must submit transcripts for each academic semester and a Deposition of Admission Documents for National Taiwan Normal University International Applicants (see Attachment V, p.27). They shall not be required to submit their diploma during the application process. However, their diploma and transcripts for each academic semester must be submitted upon registration at NTNU (diplomas or degree certificates from Mainland China are required to be notarized by the relevant authorities), otherwise their admission to NTNU will be revoked.
 - *NTNU holds the right to request applicants to have their degree certificate or diploma authenticated by the ROC diplomatic missions should NTNU find any problem in the applicants' documents.
- ③A financial statement: a minimum of NTD 100,000 (or USD 3,000) is required. Please select one of the following ways of submission:
- ①An official financial statement issued within the past three months from a financial institution.
- (2) If the financial statement provided is not under the name of the applicant, please submit: 1.the sponsor's financial statement; 2. a financial guarantee statement from the sponsor (see Attachment IV, p.26).
- ③Proof showing the applicant has been awarded full scholarship.

5.Miscellaneous

- This admission prospectus operates under the MOE Regulations Regarding International Students Undertaking Studies in Taiwan. Documents and relevant regulations will be subject to the most updated version of the MOE Regulations Regarding International Students Undertaking Studies in Taiwan.
- 2 Except for academic credentials earned at overseas Taiwan schools, academic credentials shall be subject to the *Regulations Regarding the Assessment and Recognition of Foreign Academic Credentials for Institutions of Higher Education.*
- International students admitted to NTNU will have their admissions revoked and shall be dismissed from NTNU in the following cases:
 - ()Violation of the MOE Regulations Regarding International Students Undertaking Studies in Taiwan.
 - ②Any NTNU student who is currently studying (including those who suspend their studies) or whose admission status is extended may not apply for admission to the same program of study in the same department/institute. In verified cases, the international student will have their admissions revoked, and the vacancy thus created will be filled in the order of the names as they appear on the wait list.
- Applicants must take any written exams, interviews, and/or technical tests required by the department or institute to which they are applying. A passport or other form of picture identification must be presented at the test site.
- Students who have completed the application process are not allowed to request a program change.

- Incomplete applications may be deemed as invalid. In such cases, applicants must bear full responsibility.
- Please ensure that the email address and contact phone number provided in the application system are correct. Applicants may be contacted when needed. Failing to respond within the specified deadline may result in students

forfeiting their rights and privileges.

- ③After documents are submitted, please go to the registration website at https://ap.itc.ntnu.edu.tw/istudent/apply/ to check documents submission status. If the status shows "not reviewed" or "not received," please enquire by email at intlntnu@ntnu.edu.tw.
- High school graduates whose qualifications are equivalent to Taiwan's high-school grade 5 may apply for undergraduate programs. However, admitted students shall complete at least 12 extra credits before graduation in accordance with the relevant NTNU rules and regulations.
- Students should possess basic skills in Chinese or English. When required by the relevant department or graduate institute, applicants must take a Test of Chinese as a Foreign Language (administered by the Steering Committee for the Test of Proficiency-Huayu). Those who fail to pass the proficiency level set by their department/graduate institute shall be required to take Chinese language courses as necessary.
- Students admitted to NTNU must fulfill the language requirement set by their department/graduate institute as part of its graduation requirements.
- Students admitted to bachelor programs must take and pass the course "Basic Service Learning" as part of their graduation requirements.
- If application materials are found, at any time, to contain inaccurate, false, or fraudulent information, inauthentic documents, or fail to meet admission requirements, the student in question shall have his/her admission to NTNU revoked and be dismissed from the university. Students who have already graduated will have their diploma revoked.

V: Rules Governing Admission

- 1. The final list of admitted students will be decided by the Admissions Committee. A number of candidates may be put on a waiting list in case any admitted students fail to complete registration procedures.
- 2.Individual departments/institutes may choose not to admit their full quota of students. In such cases, no waitlisted candidates will be admitted.

VI: Admission Announcements

- 1.Enrollment lists for different semesters will be posted on the application website:
- https://ap.itc.ntnu.edu.tw/istudent/apply/
- 2.Admitted students will receive notification through registered mail. Waitlisted applicants and unsuccessful applicants will be notified of the admission decision by email without additional regular mail. Applicants should check their admission status online and ensure the email address provided in their application is valid.

VII: Registration

 1.Admitted students are required to complete online registration before the stated deadline at: https://ap.itc.ntnu.edu.tw/ istudent/apply/. Students failing to complete the New Student Confirmation Form online will be regarded as having voluntarily forfeited their admission status. Vacancies resulting from students who have forfeited their admission will be filled in the order of the names as they appear on the wait list. Students hoping to retain their name on the wait list must complete an online confirmation procedure before the specific deadline as outlined in the notification letter; otherwise, students shall forfeit their place on the wait list. Waitlisted students who are admitted to NTNU will receive an additional notification letter and shall be required to complete relevant registration procedures before the closing date for registration, which is the first day of class of the current academic year as specified by the annual school calendar. Students who fail to register by this date will be seen as having forfeited their admission to NTNU. 2.Admitted students who have completed the online New Student Confirmation Form must complete all registration and enrollment procedures before the class sign-up deadline, including applications for admissions deferral or the suspension of studies to avoid having their admission status revoked in accordance with the Admission notification regulations for confirmation and registry procedures. Those applying with diplomas or degree certificates from Mainland China and who have not had their documents notarized by the relevant authorities by the application deadline shall present the notarized documents to the Office of International Affairs within one month from the day 9

- of the announcement of admission results, otherwise their admissions status will be revoked. Applicants graduating at the end of the current academic year must have their documents reviewed by the Office of International Affairs before registration or their admission status will be revoked.
- 3.According to the *MOE Regulations Regarding International Students Undertaking Studies in Taiwan*, upon enrollment admitted students must provide proof of medical and personal accidental insurance from their home country valid from the date they enter into the R.O.C. and up to at least six months or purchase six-month medical and accidental insurance coverage through NTNU. Students already insured by the R.O.C.'s national health insurance must also provide proof of insurance. If the proof of insurance is issued outside of Taiwan, it should be verified by R.O.C. diplomatic missions in the country where the document was issued.
- 4.Admitted students who are unable to register by the registration deadline and would like to extend their admission status to the following academic year must apply for an extension with the Division of Registry, Division of Graduate Studies under the Office of Academic Affairs at the main campus, or the Division of Academic Affairs for Gongguan Campus before the first day of class of the original semester in which the student was to commence their studies. Please note that not all departments/graduate institutes allow the extension of admission status. (Please refer to respective remarks of the department/graduate institute listed on the website: https://ap.itc.ntnu.edu.tw/istudent/apply/) Students whose application for admission status extension are approved by the university may begin procedures for entering the university the following academic year in accordance with the rules and regulations that apply to all new students for that year.
- 5.When required by their department/graduate institute, admitted students must register with the Steering Committee for the Test of Proficiency-Huayu to take a Test of Chinese as a Foreign Language (TOCFL). Students shall be required to pay for the test themselves. Please visit the following website for registration periods and more details: http://www.sc-top.org.tw
- 6. Transferring credits from other colleges/universities will be governed by the related regulations of this University.
- 7.Admitted students should inquire at R.O.C. missions overseas to see if language proficiency test certificate is required for visa application. A lack of required documents may lead to a failure in obtaining a visa for your study at NTNU.
- 8.Obtaining an admission permit to NTNU does not guarantee the issuance of a Resident Visa. Obtaining a Resident Visa does not entitle the visa holder to enter the R.O.C. (Taiwan). Visa issuance is an act of sovereignty. According to the *Statute Governing Issuance of R.O.C. Visas in Foreign Passport* and *Enforcement Rules for the Issuance of R.O.C. Visas to Foreign-Passport Holders*, the R.O.C. reserves the right not to issue a visa and is under no obligation to disclose the reason. If there is any problem related to visa issuance, admitted students should inquire at their R.O.C. overseas diplomatic mission for inquiries.

VIII: Miscellaneous

- 1.For admission results appeals, procedure or gender inequality, applicants may submit a written statement to the Office of International Affairs within 15 days of admission notification. Anonymous appeals shall not be processed.
- 2. Issues not covered in these guidelines are either prescribed in the *Admission Regulations for International Students of NTNU* or left to the discretion of the NTNU Admissions Committee.
- 3.In the event of discrepancies between the Chinese version and the English version of this Prospectus, the Chinese version shall prevail.

MOE Regulations Regarding International Students Undertaking Studies in Taiwan

* Notes: In the event of discrepancies between the Chinese version and the English version of this Regulation, the Chinese version shall prevail.

Amended on September 8, 2017

Article 1 These Regulations are formulated in accordance with the provisions of Article 25, Paragraph 3 of the University Act, Article 32, Paragraph 1 of the Junior College Act, Article 41, Paragraph 1 of the Senior High School Education Act, and Article 6, Paragraph 3 of the Primary and Junior High School Act. Article 2 A person of foreign nationality who has never held Republic of China ("R.O.C.") nationality and who does not have overseas Chinese student status at the time of their application is permitted to apply for admission to an educational institution, in accordance with these Regulations. A person of foreign nationality who meets the following requirements and who in the immediate past has resided overseas continuously for at least six years is also permitted to apply for admission to an educational institution, in accordance with these Regulations. However, a person who plans to apply to study in a university department of medicine, dentistry, or Chinese medicine must have resided overseas continuously for at least eight years. 1. A person who at the time of their application also holds dual R.O.C. nationality shall have never had household registration in Taiwan. 2. A person who before the time of their application also held dual R.O.C. nationality but no longer does at the time of their application shall have renounced their R.O.C. nationality with the approval of the Ministry of the Interior on a date at least eight full years before making their application. 3. The persons referred to in the preceding two subparagraphs must have never previously undertaken studies in Taiwan as an overseas Chinese student nor have accepted a placement by the University Entrance Committee for Overseas Chinese Students in the current academic vear A foreign national who was selected by a foreign government, organization, or school to study in Taiwan in accordance with the Education Cooperation Framework Agreement, and who has never had household registration in Taiwan may be given exemption from the restrictions set out in the preceding two paragraphs if the competent education administrative authority gives approval. The periods of six years and eight years stipulated in Paragraph 2 shall be calculated using the starting date of the semester (February 1, or August 1) as the end date of the period. The term "overseas" used in Paragraph 2 refers to countries or regions other than the Mainland Area, Hong Kong, and Macau; the term "reside overseas continuously" means that an international student has stayed in Taiwan for no more than a total of 120 days in each calendar year. When calculating the number of consecutive years spent overseas, if the initial or final year of the period is not a complete calendar year, any time spent in Taiwan in the initial or final year must not exceed 120 days. However, time that a person has spent in Taiwan is not subject to this restriction and it is not counted when calculating how long they were in Taiwan in a particular year if the person has documentary proof that they: 1. Attended an overseas youth training course organized by the Overseas Compatriot Affairs Council or a technical professional training program accredited by the Ministry of Education; 2. spent a total period of less than two years undertaking Chinese language classes at a Chinese language center at a university or tertiary college which has Ministry of Education approval to recruit students overseas; 3. spent a total period of less than two years in Taiwan as an exchange student; or 4. spent a total period of less than two years undertaking an internship that they came to Taiwan to undertake with the approval of the designated central competent authority; A person who held both foreign and R.O.C. nationalities and applied for annulment of their R.O.C. nationality before the date of effect of the February 1, 2011 amendment to these Regulations may apply for admission as an international student in accordance with the provisions in place before the amendment and is not subject to the restrictions set out in Paragraph 2. Article 3 An applicant of foreign nationality, who is eligible for permanent residence in Hong Kong or Macao, who has never had household registration in Taiwan, and who at the time of their application has resided in Hong Kong, Macao, or elsewhere overseas continuously for at least six years may apply for admission in accordance with the provisions of these Regulations. However, a person who plans to apply to study in a university department of medicine, dentistry, or Chinese medicine must have resided overseas continuously for at least eight years. The term "resided [...] continuously" in the preceding paragraph means that a person did not spend more than a total of 120 days in Taiwan in each calendar year. However, this restriction does not apply if a person can present documentary proof that any of the circumstances listed in Paragraph 5, Subparagraphs 1 to 4 of the previous article apply. The time that they spent in Taiwan in the ways listed is not counted when calculating the period of continuous residence referred to in the previous paragraph. A person who was formerly from the Mainland Area and who has foreign nationality and has have never had household registration in Taiwan, and who at the time of their application has resided overseas continuously for at least six years may apply for admission to an educational institution, in accordance with the provisions of these Regulations. However, a person who plans to apply to study in a university department of medicine, dentistry, or Chinese medicine must have resided overseas continuously for at least eight years. The term "resided [...] continuously" in the preceding paragraph means that a person did not spend more than a total of 120 days in Taiwan in each calendar year. However, this restriction does not apply if a person can present documentary proof that any of the circumstances listed in Paragraph 5, Subparagraphs 1 to 4 of the previous article apply. The time that they spent in Taiwan in the ways listed is not counted when calculating the period that they resided continuously overseas referred to in the previous paragraph. The periods of six years and eight years stipulated in Paragraph 1 and in Paragraph 3 shall be calculated using the starting date of the semester (February 1, or August 1) as the end date of the period.

The definition of "overseas" given in Paragraph 5 of the previous article also applies, mutatis mutandis, to Paragraphs 1 to 4.

Article 4	An international student applying to study at an educational institution in Taiwan in accordance with the provisions of the two previous

Article 26	The provisions of Article 7, Paragraph 4, Subparagraphs 1, 3, and 4, and of Articles 9, 15, 16, 22, and 24 also apply, mutatis mutandis, to the application procedures, scholarships and subsidies, supervision and guidance, absences from one quarter or more of the total scheduled class hours of a semester, and the reporting of changes to or loss of student status for international students who come to Taiwan to study Mandarin at a Chinese Language Centers affiliated with a university or tertiary college in Taiwan.
Article 27	The format of the forms referred to in Article 7, Paragraph 1, Subparagraph 1; in Article 18, Paragraph 1, Subparagraph 1; and in Article 20, Paragraph 1, Subparagraph 1 shall be determined by each educational institution. The format of the forms referred to in Article 18, Paragraph 1, Subparagraph 5 and 6 shall be prescribed by the Ministry of Education.
Article 28	These Regulations shall take effect on August 1, 2012. The amendments to these Regulations shall take effect on the date of promulgation, with the exception of the amendments promulgated on December 24, 2012 which shall take effect on January 1, 2013, and the amendments promulgated on August 23, 2013 which shall take effect on September 1, 2013.
